Amendments to The Asbestos Control Regulations

The Department of Public Health and Board of Health's Asbestos Control Regulations, effective May 22, 1989, as subsequently amended, are hereby further amended as follows (deletions in Strikethrough; additions in Italicized):

SECTION X. ASBESTOS INSPECTIONS AND REPORTS

A. General.

1. An asbestos inspection report *including all laboratory sample reports and analyses* shall be required prior to issuance of a permit for demolition or alteration which requires the filing of plans. This does not apply to buildings for which a building permit was issued after December 31, 1980 or any residence with three (3) dwelling units or less. For the purpose of these Regulations asbestos inspections shall be made only by an independent certified asbestos investigator.
